#### Job description (Please contact Melissa Rupert if you're interested in applying.)

SevenGen is seeking a talented and motivated industrial hygienist for an exceptional full-time opportunity supporting the EHS Team at GE Aviation. You will be working at the GE campus located in Cincinnati, Ohio, while supporting GE's team of highly skilled Environmental, Health & Safety (EHS) professionals. You will be assisting in the management of industrial hygiene programs at a world-renowned organization that is known for their position at the leading edge of science and technology. Successful applicants will be vetted and hired through SevenGen.

#### What does your workday look like?

If you're looking for variety in your next position, then this is the job for you! In this job you will be heavily engaged in a diverse environment of occupational health hazards. Your workdays may be spent doing the following:

- Conducting personal noise dosimetry measurements on workers and completing area sound level measurements in a variety of areas. You will apply dosimetry results against applicable regulations and industry standards, recommend noise abatement measures as applicable.
- Performing heat stress surveys using wet and dry bulb thermometers and making recommendations regarding work safety in inclement weather.
- Performing various regularly scheduled and ad hoc onsite safety and industrial hygiene compliance audits at the Evendale campus and other GE Aviation sites, as needed. While these audits will be performed under the supervision of a GE IH, you will need to work autonomously in many instances.
- Working with GE Departments such as Security, Fire Protection, Test, Facilities, Manufacturing etc. to meet site specific EHS, security, and area-specific operational requirements.
- Assisting in maintaining GE Evendale's OSHA Voluntary Protection Program certification by sitting on GE VPP teams. You must be able to assist in the preparation of GE's records for VPP audits and answer questions about the GE industrial hygiene program in order to assist GE as needed during OSHA VPP audits.
- Assisting GE EH&S with incident investigations involving injuries, property damage, security concerns, etc.
- As needed, using instrumentation to measure for radiation sources and performing surveys of the equipment onsite containing radioactive sources and report the survey results. You will need to interpret the results against applicable regulations and industry standards.
- Performing comprehensive surveys for asbestos-containing building materials, perform thorough post asbestos abatement visual inspections, collect post abatement air samples per AHERA. You may not be certified, but you must be willing to obtain your certification.
- Collecting air, bulk and wipe samples for lead, and using X-ray fluorescence devices to measure the lead content of building materials.

#### What skills will you need?

You must be a well-rounded industrial hygienist with multi-faceted experience in core industrial hygiene skill sets. What does that mean? Let's take a look -

- Chemical exposure monitoring
- Equipment calibration and maintenance
- Chemical approvals and safety data sheets
- Indoor air quality assessments, including mold
- Occupational noise monitoring, including personal dosimetry and sound level measurements
- Bloodborne pathogens and familiarity with exposure control programs
- Heat and cold stress
- And more!.

#### What skills would be helpful? (a plus but not required)

In a field as diverse as industrial hygiene, it's likely that you are not an expert in everything. That said, there are skills that will be helpful in this job, and if you do not currently possess these skills, you must be willing to learn and become proficient in them. This might include:

- Being Certified by the Ohio Environmental Protection Agency as an Asbestos Hazard Evaluation Specialist.
- Performing Lead inspections and using X-ray fluorescence equipment for lead assessments of building materials
- Performing ionizing and non-ionizing radiation surveys
- Having a working knowledge of laser safety, including measuring laser output
- Experience working in a strong union environment

#### Who is our Candidate?

#### We are looking for a confident IH professional who:

- Able to identify health hazards and recommend strategies for reducing exposures
- Is poised under pressure and is able to confidently speak about health and safety regulations relating to industrial hygiene.
- Is personable, carries a conversation easily and is able to work in collaboration with others.
- Is able to participate in meetings at GE and address identified health issues and mitigation strategies
- Has excellent communication skills and can engage in conversation with individuals at all levels and address a diverse group of needs
- Is able to successfully build trust and navigate potentially difficult conversations
- Is able to work autonomously with regular communication to safety team and Senior Leadership.
- Shows strong initiative, working effectively without close supervision.
- Acts quickly and decisively and demonstrates confidence when addressing difficult issues.
- Is a team player with the ability to drive results and to motivate/manage the performance of others.
