An Update on Our Advisory Group

Our Advisory Group held its first-ever meeting on July 20, 2022. It was an honor to welcome this group of volunteers to this new leadership role, and we appreciate how dedicated they are to advancing the Society, representing our members and member communities, and elevating our great profession.

The creation of this group is a key outcome of our historic governance change approved by delegates earlier this year. It signals a shift in our approach to strategic planning; highlights our focus on providing members with more opportunities to share input and inform the Board of Directors' decision-making; and supports our efforts to engage more members and create a more inclusive organization.

Throughout our meetings with members prior to the governance vote and since then, we have received questions about the Advisory Group, so I would like to review some key details as the group moves forward with its operations and work plan. Member Representation

One common question relates to the composition of the Advisory Group, which currently consists of more than 330 members. Four key member constituencies are represented:

- **Chapters:** Each chapter has representation based on the size of its membership as defined in our bylaws (<https://assp.us/bylawsA-14>).
- **Common interest groups and practice specialties:** The leaders elected to serve as administrators and assistant administrators of these member communities are members of the Advisory Group.
- **Elected Society leaders:** Members elected to the offices of council vice president, region vice president and area director also belong to the Advisory Group.
- **At-Large members:** Members in good standing can comprise up to one-quarter of the Advisory Group. In the at-large role, these members represent the interests of our general membership and OSH professionals overall.

Advisory Group Work Plan

As part of the governance change, we developed an initial Society Operating Guideline (SOG) and work plan for the Advisory Group. A key step in this work plan is selecting members to serve on the Operations Committee. This committee will coordinate and facilitate meetings, track outcomes and report regularly to members, including the Board of Directors, on key performance indicators. Advisory Group members have considered two options that align with our bylaws and committee selection SOGs to move this process forward, and we expect to have this committee in place by early November.

Membership value will be a key focus of the Advisory Group during its inaugural year. We are conducting research to capture input on key challenges and opportunities related to membership, and Advisory Group members will inform board decisions in this area through surveys, interviews and town halls. Be sure to share your thoughts and ideas on this topic with your Advisory Group representatives.

The Advisory Group will also play an essential role in our strategic planning. We have two upcoming meetings with the group on this issue:

ASSP Foundation Professional Education Grant Program

- **Professional education grants** are available for individuals within the occupational safety and health field (either students or professionals) who need financial support for certification expenses, conference attendance, webinar attendance, workshop attendance, and similar professional development support.
- College courses are not covered by the professional education grant program; applicants must use the scholarship application if requesting support for college courses.
- **Applications for ASSP Foundation professional education grants are accepted year-round, with awards made on a rolling basis, based on availability.**

APPLY FOR GRANTS

ASSP Foundation Academic Scholarship Program

- **Academic scholarships** are available for students within the occupational safety and health field, preparing for their careers or looking to supplement their careers with additional college coursework.
- **Applications for ASSP Foundation academic scholarships are accepted October 15, 2022–January 31, 2023.**
- Programs of study must be either directly related to the occupational safety and health field or will be utilized to support the occupational safety and health field. This can include a variety of degrees. If your degree is not directly related to occupational safety and health, you will be asked to clarify how you will be using your degree to support the field of occupational safety and health.
- Academic scholarships are announced on or around May 15, 2022.
